Requirements for manuscripts for publication in the journal "E3S Web of Conferences", indexed SCOPUS, Web of Science:

- Scientific articles that correspond to the specialization of the conference and have scientific novelty are accepted for publication. It is not allowed to send already published articles or articles sent for publication to other publications to the organizing committee. **Example of article design** follow the link (https://esmg2023.ru/images/woc_1col.doc)

Article structure

The following sections should be highlighted:

1. Introduction;
2. Materials and Methods;
3. Results and Discussion;
4. Conclusions;
5. Acknowledgments – optional element.

The above sections are mandatory. Within these sections, subparagraphs can be highlighted and named at the discretion of the authors.

The results presented in the article must be formulated in the form of scientific statements that clearly define the essence of the contribution to science.

Procedure for accepting materials for publication

Before submitting an article for translation, you need to send the source material in Russian to the editorial committee. We strongly recommend that you do not translate the article until the review procedure is completed, since in most cases, after this, adjustments are made to the work.

Work with articles proceeds according to the following scheme:

1. Article registration
2. Checking for uniqueness (originality)
3. Review
4. Translation of the article
5. Concluding an agreement for the registration fee
6. Sending confirmation of acceptance of an article for publication

When the status of an article changes, a message is sent to the corresponding author. Articles with an originality of 75% or higher receive a positive result from the uniqueness check (anti-plagiarism). When reviewing, the compliance of the article with the requirements for publication and the topic of the conference, and the relevance of the research are assessed. Articles are published only in English. The article must be written in a language understandable to a specialist in the relevant field. The compliance of the English translation with the requirements is carried out by native speakers and professional translators.

Scientific articles (reports) must contain:

§ Name;

§ information about the authors (last name with initials; place of work, city, country; email address);

§ an abstract of 100 to 150 words;

§ list of references (minimum number - 8 references in addition to self-citations, references to Scopus, Web of Science publications are required).

Links to the sources used should be located in the order of mention in the text in the format [1], [2-6], [3, 5, 7]. You should not provide links to unpublished articles. Please provide links to Russian-language articles (magazines) that have a translated title immediately in English.

After reviewing, the article is sent for translation. The cost of translation is indicated below.

The authors format the translated article themselves according.

Article length: 5-6 full pages (font size 10 pt, single spacing).

The number of articles that an author can publish in a collection is no more than two.

The number of authors in one article is no more than five.

Articles and related documents are sent to:

The size of the organizational fee is 15,000 rubles (for 1 article in the collection of conference materials).

Translation service (if necessary) – 650 rubles for 1 conventional page (1800 characters with spaces).

Editing service (if necessary) - 2000 rubles for 1 article (if you cannot prepare an article according to the requirements of the template, you can apply for this service).

Payment of the registration fee must be made only after concluding an agreement to organize the publication. Please note that if the registration fee is not received on time, your report will not be published.

Dear colleagues, we urge you to make sure that all materials (articles) that you send to the conference editorial committee have not previously been published in any publications (including in Russian).

Abstract. You should leave 8 mm of space above the abstract and 10 mm after the abstract. The heading Abstract should be typed in bold 9-point Arial. The body of the abstract should be typed in normal 9-point Times in a single paragraph, immediately following the heading. The text should be set to 1 line spacing. The abstract should be centred across the page, indented 17 mm from the left and right page margins and justified. It should not normally exceed 200 words.

1 Page layout

Use 170 x 250 mm paper size (W x H mm) and adjust the margins to those shown in the Table 1. The final printed area will be 130 x 210 mm. Do not add any page numbers.

1.1 Formatting the title, authors and affiliations

1.1.1 Formatting the title

The title is set in bold 16-point Arial, justified. The first letter of the title should be capitalised with the rest in lower case. You should leave 22 mm of space above the title and 6 mm after the title.

1.1.2 Formatting author names and author affiliations

The style for the names is First Names, typed in italic 10-point Times, then Last Name, typed in 10-point Times, with a comma after all except the last author, which is separated by comma + "and". Do not use academic titles.

Affiliations of authors should be typed in 9-point Times. They should be preceded by a numerical superscript corresponding to the same superscript after the name of the author concerned. Please ensure that affiliations are as full and complete as possible and include the country.

1.2 Formatting the text

The text of your paper should be formatted as follows:

- 10-point Times, Times Roman or Times New Roman.
- The text should be set to single line spacing.
- Paragraphs should be justified.
- The first paragraph after a section or subsection should not be indented; subsequent paragraphs should be indented by 5 mm.

The use of sections to divide the text of the paper is optional and left as a decision for the author. Where the author wishes to divide the paper into sections the formatting shown in Table 2 should be used.

2 Figures and tables

Figures and tables, as originals of good quality and well contrasted, are to be in their final form, ready for reproduction, pasted in the appropriate place in the text. Try to ensure that the size of the text in your figures is approximately the same size as the main text (10 point). Try to ensure that lines are no thinner than 0.25 point.

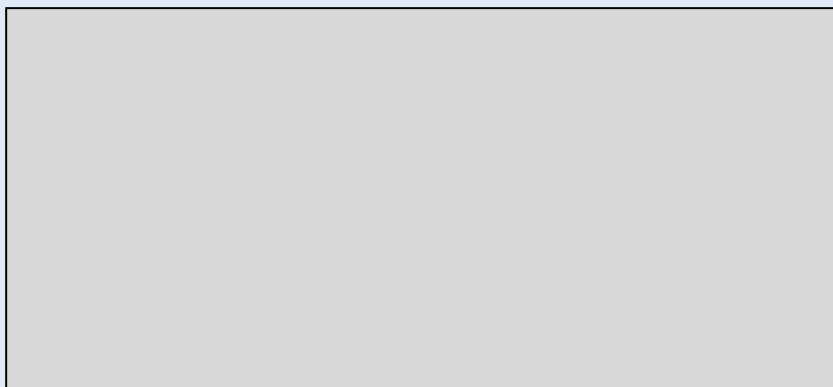
2.1 Captions/numbering

Captions should be typed in 9-point Times. They should be centred above the tables and flush left beneath the figures.

2.2 Positioning

Place the figure as close as possible after the point where it is first referenced in the text. If there is a large number of figures and tables, it might be necessary to place some before their text citation.

2.3 Colour illustrations

You are free to use colour illustrations for the online version of the proceedings, but any print version will be printed in black and white unless special arrangements have been made with the conference organiser. Please check whether or not this is the case. If the print version will be black and white only, you should check your figure captions carefully and remove any reference to colour in the illustration and text. In addition, some colour figures will degrade or suffer loss of information when converted to black and white, and this should be considered when preparing them.

3 Equations and mathematics

Equations should be centred and should be numbered with the number on the right-hand side.

$$T_s(l,t) = T_g(l,t) \quad (1)$$
$$T_s(l,t) = T_g(l,t) T_b(x \square \square t) = 0 \quad (2)$$

Use italics for variables (*u*) and bold (**u**) for vectors. The order for brackets should be $\{[()]\}$, except where brackets have special significance.

The acknowledgements should be typed in 9-point Times, without title.

References

Online references will be linked to their original source, only if possible. To enable this linking extra care should be taken when preparing reference lists.

References should be cited in the text by placing sequential numbers in brackets (for example, [1], [2, 5, 7], [8-10]). They should be numbered in the order in which they are cited. A complete reference should provide enough information to locate the article. References to printed journal articles should typically contain:

- **The authors, in the form: initials of the first names followed by last name (only the first letter capitalized with full stops after the initials),**
- **The journal title (abbreviated),**
- **The volume number (bold type),**
- **The article number or the page numbers,**
- **The year of publication (in brackets).**

Authors should use the forms shown in Table 3 in the final reference list.
